4. The personal data we collect about you

- 4.1. Personal data is any information which directly or indirectly identifies an individual, for example, your name, address, email address or contact details. This does not include any information that does not, and cannot be used to, identify an individual.
- 4.2. You give us your personal data through your use of our Website or when you visit one of our premises in person.
- 4.3. We also collect personal data from you indirectly such as your browsing activity while on our Website. Please see the Cookie Section below for more information.
- 4.4. We also collect personal data from other sources as set out below.

5. Personal data collected directly from you

8. How long will personal data be retained?

8.1. We keep personal data that we obtain about you for no longer than is necessary for the purposes for which it is collected. How long we keep your information will depend on the nature of the information concerned and the purposes for which it is processed.

9. Sharing your personal data

- 9.1. The Fresca Group may share your personal data with third-party processors who provide services to us. These services include third parties who provide outsourced operational services to us and the companies within the Fresca Group.
- 9.2. We may share your personal data with organisations where we have a legal obligation, contract or other legitimate interest to do so.
- 9.3. Your personal data may be transferred to other third-party organisations in certain scenarios, for example:
 - (a) if we are discussing selling or transferring part or all of our business, personal data may be transferred to prospective purchases under suitable terms as to confidentiality;
 - (b) if we are reorganised or sold, personal data may be transferred to a buyer who can continue to provide services to you;

- (c) if we are required to by law, or under any regulatory code or practice we follow, or if we are asked by any public or regulatory authority, for example the police, we may need to share your personal data; or
- (d) if we are investigating or defending any legal claims your personal data may be transferred as required in connection with defending such investigations and/or claims.

10. Transferring data overseas

- 10.1. In some cases, we may need to transfer personal data outside United Kingdom (**UK**). Where this is the case, we will only share the minimal amount of personal data necessary for the purpose of processing and, where possible, we will share the personal data in an anonymised form.
- 10.2. Whenever we transfer your personal data out of the UK, we ensure a similar degree of protection is afforded to it by ensuring at least one of the following safeguards is implemented:
 - (a) we may transfer your personal data to countries for whom there has been an adequacy by the UK Secretary of State (as applicable) confirming that that country provides an adequate level of protection for personal data;
 - (b) we may use specific contracts approved by the UK Data Protection Laws (as applicable) which give personal data the same protection it has within UK. When we rely on this measure, we will ensure that the third-party can comply with the provision of such contracts and we have confirmed that the country to which the personal data is transferred provides enforceable data subject rights and effective legal remedies for data subjects are available there; or
 - (c) a specific exception applies under applicable data protection law.

11. How we protect your personal data

- 11.1. We have appropriate security measures in place to prevent personal data from being accidentally lost or used or accessed in an unauthorised way. We limit access to your personal data to those who have a genuine business need to know it. Those processing your information will do so only in an authorised manner and are subject to a duty of confidentiality.
- 11.2. We also have procedures in place to deal with any suspected data security breach. We will notify you and any applicable regulator of a suspected data security breach where we are legally required to do so.

12. Marketing

We would like to send you information about products and services and events which may be of interest to you. Where we have your consent, we may do this by post, email or telephone. We will always treat your personal data with the utmost respect and never sell or share it with other organisations for marketing purposes. We will ask whether you like us to send you marketing messages when you subscribe to receive our latest news and events on our website. If you have agreed to being contacted in this way, you can unsubscribe at any time by:

(b) using the 'unsubscribe' link in emails or communications we send to you.

13. Cookies and similar tracking devices

- 13.1. Cookies are small files of letters and numbers stored on your browser or device These cookies are used to ensure that you are sent the correct content when your computer requests it. Some cookies are essential to enable you to move around our Website and use its features and/or services. For example we will use a cookie to remember your selections as you move through our website.
- 13.2. When you first visit our website, you will be provided with information about the cookies we use and to manage your cookie preferences.
- 13.3. You can also click on Cookie Policy Fresca Group to view a current list of our cookies.

14. Your rights

- 14.1. Under data protection laws, you have rights including:
 - (a) Your right of access You have the right to ask us for copies of your personal data.
 - (b) Your right to rectification You have the right to ask us to rectify personal data you think is inaccurate. You also have the right to ask us to complete personal data you think is incomplete.
 - (c) Your right to erasure You have the right to ask us to erase your personal data in certain circumstances.
 - (d) Your right to restriction of processing You have the right to ask us to restrict the processing of your personal data in certain circumstances.
 - (e) Your right to object to processing You have the right to object to the processing of your personal data in certain circumstances.
 - (f) Your right to data portability You have the right to ask that we transfer the personal data you gave us to another organisation, or to you, in certain circumstances.
 - (g) Rights related to automated decision making, including profiling You have the right not to be subjected to a decision based solely on automated processing (including profiling) which may significantly affect you.

In most cases we will deal with your request as soon as possible and at the latest within one calendar month of the request. If we need to extend the time period for responding to your request, we will let you know within the one-month period. We do not charge a fee for any such requests unless there are exceptional circumstances.
